Action Items from May 21, 2024 meeting

- Voted to hire Kaylee Chaban and Nicole Tinna to full time C&Y caseworker 1. Both were formerly interns and have decided they would love to continue working for the county.
- Voted with much reluctance to accept the resignation of Beverly "Sue" Howell as long time Admin Assistant for EMA effective June 3, 2024. Good luck in your well deserved retirement!
- Voted to promote Terry Anderson and Lloyd Burton from Telecommunicator 1 to Telecommunicator 2. Both have successfully completed all certifications.
- Voted to hire Vickie Green and Jeffrey Tilghmam as a prison C.O.
- Discussed and voted to replace the current records management system in the Sheriff's office at a cost of \$2,350 or \$350 per full time deputy per year. Funds for initial purchase will be taken out of ACT 13 funds and annual costs in the same amount will be requested in the annual Sheriff's office budget.
- Voted to approve expenditures of \$50,218 and \$780 from the Opioid settlement fund for purchase of Deterra pouches to be distributed to the county.
- Discussed and voted to distribute county liquid funds to townships and boros bases on mileage in each and population in each in the total amount of \$50,000.
- Voted to name Paul Rowker to empty position on Wyoming County Seneca Park board
- Voted to extend contract with Beach Lake Sprinkler for required annual inspections. For the courthouse, \$960 and for Emergency Operations Center \$1,685.
- Announced successful completion of required recertification of our 911 Emergency Communications Center for
  meeting all required training and certifications requirements. This recertification is conducted every 2 years and
  we are compliant through March 25, 2026. Congratulations to 911 Director Jeff Porter and all of his staff for a
  job well done.
- Voted to replace servers that have reached end of life. Service will no longer be available after June 30. Total
  cost is \$122,933.81. Need down payment of \$50,000 to order. A portion of this may be taken out of the records
  improvement fund with the remainder coming out of ARP. Records improvement committee will be meeting
  soon to decide.

- Voted to provide a letter of consent for the Daughters of the American Revolution to add a 4<sup>th</sup> commemorative tablet naming 15 additional Revolutionary War patriots that have been identified in Wyoming County. This will be in conjunction with America 250 celebration.
- Voted to hire Karen Snyder as Deputy Chief Clerk effective 5/20/24
- Voted to hire April Darrow as Admin Assistant in Commissioners office effective 6/3/24
