- Discussed and approved the intermunicipal cooperation agreement between Tunkhannock Borough Municipal Authority, Tunkhannock Borough and Wyoming County for the project to separate stormwater/sewer discharge water as required by new EPA regulations. Funds to be paid from federal grant from EPA
