Action Items from August 18, 2026 meeting

- Discussed and voted to approve payment of the bills
- Discussed and voted to approve unpaid leave for CO Alexandria Jervis Belch for her wedding and honeymoon that were planned before she took the position
- Discussed and voted to hire Larry Spathelf as Insurance Fraud Task Force detective to fill open position. This is a reimbursed program at no charge to county including all benefits
- Discussed and voted to approve replacement of 2 drones at a cost of \$18,764 less trade in of \$5,700. To be paid for out of state 911 special projects fund.
- Presented check to Jeff Swire for Patriots Cove from America 250 profit proceeds
- Discussed and voted to hire Michael Cowley as part time law clerk to fill existing vacant position
- Discussed and voted to extend purchase of service agreements with the following for Children and Youth:
Family Care for Children and Youth, Dr. Matthew Schaffer, Valley Youth House and Occucares
- Discussed and voted to Repair correctional facility Boiler Flue Collector at a cost of \$13,417

During the closure and while Eaton Township replies to DEP, the Park Board will continue to look for ways to ensure the park remains clean, safe, functional and welcoming for all visitors while also protecting the natural environment.
- Discuss and vote to hire Cadence Smith as a full time correctional officer and Melissa Gast as a part time correctional officer
- Discuss and vote to accept the resignation of Goran Lazarevic as a FT Correctional Officer
