- Discussed and voted to approve payment of the bills
- Discussed and voted to close Seneca Park until further notice due to the recent complaint submitted to DEP regarding the repeated use of makeshift bathrooms in the park. During the closure and while Eaton Township replies to DEP, the Park Board will continue to look for ways to ensure the park remains clean, safe, functional and welcoming for all visitors while also protecting the natural environment.
- Discussed and voted to hire Cadence Smith as a full time correctional officer and Melissa Gast as a part time correctional officer
- Discussed and voted to accept the resignation of Goran Lazarevic as a FT Correctional Officer
- Discussed and voted to accept the resignation of Christine Messner as Admin Assistant/Court Reporter
- Discussed and voted to approve the transfer of Emily Podminick from full time to part time in Nurse Family group
- Discussed and voted to encumber an additional \$100,000 for bridge repairs from liquid fuels funds bringing total of \$365K for Bridge 5 and \$155K for Bridge 6, both on Creek Flats Drive in Falls Township
- Discussed and voted to adopt a resolution authorizing the sale of the Department of Agriculture Building and property owned by the county to Tunkhannock Township for \$187,398.25 which is the amount the county has invested into the property
