1. TO VOTE YOU MUST BLACKEN THE OVAL TO THE LEFT OF YOUR CHOICE COMPLETELY. An oval blackened to the left of the name of any candidate indicates a vote for that candidate.

2. To cast a write-in vote for a person whose name is not on the ballot, you must blacken the oval to the left of the line provided, and write the name in the blank space provided for that purpose.

3. Mark ballot only in blue or black ink. Use the same pen for all markings you place on the ballot.
