Filing a Petition for Amendment of Marriage Record

Completing the Petition:

- 1. Near the top of the first page, after the words "In Re:" write "Marriage Record of" and then your name. Include your spouse's name if you are filing it together.
- 2. After the words "Marriage License No." write your Marriage License Number.
- 3. Leave the space after the letters "OC" blank. This is where the Orphans' Court Clerk will place a docket number when you file the Petition.
- 4. In the introduction paragraph, write your name and, if you are filing the Petition with your spouse, write your spouse's name.
- 5. In Paragraph 1, write your address and telephone number. If you are no longer married, cross out "and Applicant B and the word "married."
- 6. In Paragraph 3, write the county you were married in the first blank, then the date of marriage in the second blank.
- 7. In Paragraph 4, write your names as they appear on the original marriage record.
- 8. In Paragraph 5, describe the item(s) to correct, how it currently appears and how it should be corrected.
- 9. In Paragraph 6, attach a copy of the original record and application.
- 10. In Paragraph 7, list the items you are attached as proof for the correction. (i.e., driver's license, passport, social security card, birth certificate)
- 11. Paragraph 8, describe the reason(s) you are asking for the correction.
- 12. Print your names on the lines for Applicant A (and Applicant B, if applicable). Write your address and telephone. Put the date you are filing the Petition.
- 13. On the Verification page, print your name on the line for Applicant A and if your spouse is also filing, print your spouse's name on the line for Applicant B. (If your spouse is not filing with you, leave the line blank). Sign on the line above "Signature of Applicant A" and, if applicable, have your spouse sign on the line above "Signature of Applicant B." Write the date in the space to the left of the signature(s).

Completing the Order:

1. Fill out the top part of the Order, just as you did the Petition.

When the above is completed, make two (2) copies of the Petition. (original to be filed, a copy for the Judge and a copy to be returned to you.)

Bring all of the documents to the Clerk of Orphans' Court for filing. You will have to pay a filing fee of \$20.00.

The Orphans' Court Clerk will send the Petition to Court Administration, along with the proposed Order. Once the Order is signed, we will mail you a copy of the same and will correct the original marriage record.
