Where no fee is specified the fee shall be set by the Recorder of Deeds

All recording fees must be for the exact amount. We do not give refunds. We will keep any overages \$5.00 or less. If your overages are over \$5.00 your document(s) will be returned. Checks should be made payable to the Wyoming County Recorder of Deeds.

All instruments MUST be legible and able to be scanned clearly to our system. Illegible documents will be rejected. Font size of 9 or larger is required on all documents. A ½ margin across the top of every page is required for recording purposes. Colored documents are not acceptable for recording.

Realty Transfer Tax

A state tax of 1% of the consideration and a local tax of 1% (totaling 2%) is due when recording. All deeds shall set forth the true consideration or be accompanied by a "Statement of Value". If an exemption is claimed, either full or partial, the deed must be accompanied by a "Statement of Value". The "Statement of Value" shall be fully completed in duplicate. Where the property is located in two or more taxing authorities, the person recording the deed shall indicate thereon the value of the property in each taxing authority for local realty transfer tax purposes. If the deed is taxable and located in Windham Township a "statement of Value" is required to indicate the correct school district for the property.
