NOTIFICATI	ON OF REGISTRATION AND VERIFICATION REQUIREMENTS UNDER 42 Pa. C.S. Section 9799.10 et seq.	
	o 42 Pa. C.S. Section 9799.10 et seq., having been convicted of a sexual g registration, you are hereby informed of the following responsibilities:	
Pennsylvania State	e you are classified as a Tier offender, you must register with the e Police (PSP) for a period of years (Tier III offenders and Predators must register for life), and furnish the following required registration	
a.	Primary or given name, including any aliases, nicknames, pseudonyms, ethnic or tribal names;	
b.	Your designation used for purposes of routing or self-identification in Internet communication or postings;	
c.	Telephone number, including cellular phone number, and any other designation used for purposes of routing or self-identification in telephonic communications;	
d.	Valid Social Security Number issued to you by the Federal Government and purported Social Security Number;	
e.	The address of each residence or intended residence;	
f.	If you are transient, or in other words you are homeless, in addition to reporting to the PSP every 30 days, you shall provide information about your temporary habitat or other temporary place of abode or dwelling, including but not limited to, a homeless shelter or park. Under these	

circumstances, you will also be required to provide a list of places where you eat, frequent, and engage in leisure activities and any planned destinations, including those outside this Commonwealth. If you change or add to the places previously listed during a 30 day period, you will be required to list those places when registering again during the next 30 day period. In addition, you will be required to provide the location where you receive mail, including a post office. If you have been designated as a Sexually Violent Predator, you shall state whether you have been complying with the requirements relating to the counseling of sexually violent predators. You will be required to comply with these requirements until you establish a residence;

- g. If you will be living in temporary lodging, you will be required to provide the specific length of time and dates during which you will be temporarily lodged;
- h. A passport and documents establishing immigration status;
- I. The name and address where you are employed or will be employed. If you are not employed in a fixed workplace, you are required to provide information regarding general travel routes and general areas where you work;
- j. Any information relating to occupational and professional licensing, including the type of license held and the license number;
- k. The name and address where you are or will be enrolled as a student;
- 1. Information relating to motor vehicles you own or operate, including watercraft and aircraft, which shall include a description of each vehicle, watercraft or aircraft; license plate, registration, or other identification number and the address of the place where a vehicle is stored; and any and all licenses issued to operate any vehicles regardless of the jurisdiction from which they have been issued from;
- m. Actual date of birth or purported date of birth; and
- n. The form signed by you acknowledging your obligations which are being described to you right now.



2. You will also be required to inform the PSP in person within three (3) business days of any changes in the aforementioned registration information.

The period you are required to register will be tolled should you be: incarcerated in a State or County Correctional Institution, subject to a sentence of Intermediate Punishment which is restrictive and where you would be sentenced to a period of incarceration, committed to an institution or facility set forth under the Juvenile Act, committed to and receiving involuntary inpatient treatment in a State-owned facility or Unit relating to court-ordered involuntary treatment of certain sexually violent persons, or if you are committed to a State or County Correctional Institution for a parole violation, or if you are sentenced to an additional term of imprisonment. Your registration period does not begin until release from incarceration, your parole, or if you are sentenced to probation or intermediate punishment.
4. If you are sentenced to a period of incarceration, you must complete your initial registration immediately upon sentencing. If you are sentenced to a period of probation or county Intermediate Punishment, you must report to an approved registration site and complete your initial registration within 48 hours of sentencing.

5. Regardless of when you provided updated information as set forth in Paragraph 1 above, you will still be required to appear in person at an approved registration site to be photographed and to verify and provide information as follows: a. Tier I offender: Annually (once a year) b. Tier II offender: Semiannually (twice a year) c. Tier III offender: Quarterly (four times a year) d. A person who resides, works, or is a student in Pennsylvania and has been convicted of an offense requiring registration in another state or country, but such offense is not set forth as one of the offenses requiring registration in Pennsylvania: Annually (once a year) e.
